Legislation

Many of you may have heard that there is currently legislation moving through the House and Senate that would make changes to Early Childhood Iowa as we have known it for the past 27 years.

The bill recommending the changes is coming from the Governors Office. The first committee meetings on the bills were held the week of February 17th.

While nothing is final until bills are signed the ECI State Office is preparing ECI areas for the changes.

The most noticeable change is to move from 33 ECI areas to 7 Districts using the map that was created for the Behavioral Health Districts. With that changes Partnerships 4 Families as we know it would be divided into three Districts.

District 1 Carroll County
District 4 Audubon & Guthrie
District 5 Greene County

As we wait and see what will happen in the legislator meetings are being held to make transitions go smoothly should the change occur.
