Partnerships 4 Families is the Early Childhood Iowa Area for Audubon, Carroll, Greene and Guthrie Counties. We were designated a site in 1998. Since 1998 we have received over \$11 million dollars in funding from the State of Iowa that has provided home visitation services to families, increased the quality of childcare, provided tuition and transportation assistance to preschool families, and encourage prenatal mothers to provide a health environment for their unborn children. We have also built a network of early childhood providers that work together for the needs of the children in our four county area.

The P4F Board is looking for persons willing to represent the children as a board member. We meet 8-10 times year most recently in Carroll but we may consider moving our meeting around in our counties. The meetings are from 10:30 to noon on the third Friday of the month.
